**Re: Polar Capital Funds plc (the “Company”),
Healthcare Blue Chip Fund (the “Fund”)**

Dear Shareholder,

We are writing to you in your capacity as a Shareholder in the Fund to advise you of a number of proposed changes to the Supplement of the Fund, summarised as follows:

- **Change of Name of Fund:** It is intended that the name of the Fund be amended to “Global Healthcare Select Fund”. The revised name is reflective of the geographical focus of the Fund and minor updates being made to the investment strategy of the Fund to reflect the Investment Manager’s selection of investments for the portfolio.
- **Removal of Performance Fees:** Performance fees will no longer be charged on any Classes.
- **Fee Reduction for Class I Shares:** The investment management fee payable in respect of Class I Shares is being reduced from 0.85% to 0.70%
- **Establishment of Additional “Super-Institutional” Share Class:** An additional Share Class is being established, namely, Class SI Euro Accumulation Shares, with a \$50,000,000 minimum investment (or the Euro equivalent of \$50,000,000):
- **Closure of certain founder Share Classes:** The following Class S Shares have been voluntarily fully redeemed and will not be relaunched. Accordingly references to same are being removed from the Supplement.
 - Class S USD Distribution Shares
 - Class S USD Accumulation Shares
 - Class S Hedged GBP Distribution Shares

The purpose of this letter is to provide notification to each Shareholder of the proposed updates being made to the Supplement for the Fund. Shareholders are not required to take any action in response to this letter.

Details of the existing Share Classes may be found in the attached Appendix.

The proposed change of name of the Fund is subject to the approval of the Central Bank of Ireland (the “Central Bank”), and the additional proposed updates to the Fund Supplement as described above are subject to clearance by the Central Bank. It is expected that the changes will be effective on or about 29 April 2026.
